From 20.12.2020 to 23.12.2020, Owing to the COVID-19 Pandemic, keeping in mind the current difficult times and the motto of the District Legal Services Authority, DLSA North East organized 04 Help Desks in North East Area for providing necessary assistance & aid to the "Construction Labour" for getting them issued a "Labour Card".
- 6. From 20.12.2020 to 24.12.2020, In pursuance to this holy cause, DLSA North East under the aegis of DSLSA organized a campaign to sensitize poor and marginalized

sections and in particular the pavement dwellers about their right of availing the government provided facilities of Shelter Homes. In this pursuit and in continuation of "PROJECT AASRA" DLSA North East organized Project AASRA-III. Vide this campaign the DLSA North East aims to reach out to each pavement dwellers in the North East district and inform them about the location, benefits and facilities of the shelter homes, besides making them aware of their legal rights and encouraging them to shift from pavements to the nearest Shelter Homes.

- 7. On 21.12.2020, Ld. Secretary, DLSA North East attended a meeting on Virtual Meeting-cum-Refresher Programme on "Referral of Matters for Virtual/ Physical Mediation Post COVID-19 organized by the Office of the Principal District & Sessions Judge, East District, Karkardooma Courts, Delhi.
