District and Sessions Judge examined the current situation in

Jail number 11 and 12. It was resolved that Jail Superintendent with the aid of DLSA counsels shall endeavour to move maximum bail applications for the inmates, as per the guidelines of the Delhi High Court and the High Powered Committee. It was further resolved that the data be shared with the Central Office, DSLSA. It was resolved that apart from the applications for interim bail, applications shall also be moved for bails on merits, through the DLSA advocates posted in jails. The committee thanked the Jail Staff and DLSA for making sincere efforts, which caused the reduction in jail population even below the sanctioned strength.

The meeting ended with a vote of thanks to the chair.

#### **8.** 30.06.2021

Even though the lockdown does not exist any more, the scare caused by the Global pandemic is far from being gone; with explosive rise in numbers, the situation is getting critical each day, yet the Justice delivery system cannot come to a hault. Come what may, we are obliged to do our jobs in the manner best suited to the Interest of Justice. On 30<sup>th</sup> June 2021, Delhi Victim Compensation Committee, North East District, was held. The committee had 09 matters before it, affective orders were passed in all matters.
