In view of this DLSA North East deputed 4 PLVs to coordinate/ assist the team and further thereof DLSA North East has also sent 150 Color Books and 150 Blankets to the O/o District Magistrate, North East for the distribution to the CISS.
- <u>3. 07.01.2022, 17.01.2022, 22.01.2022 &</u> 29.01.2022 DLSA NORTH EAST, through Secretary, convened the weekly meeting of Under Trial Review Committee, under the chairmanship of the Ld. District and Sessions Judge Sh Ramesh Kumar, as per the directions of the Supreme Court. The meeting was conducted through a whatsapp. Ld District and Sessions Judge examined the current situation in Jail number 11 and 12. It was resolved that Jail Superintendent with the aid of DLSA counsels shall endeavour to move maximum bail applications for the inmates, as per the guidelines of the Delhi High Court and the High Powered Committee. It was further resolved that the data be shared with the Central Office, DSLSA. It was resolved that apart from the applications for interim bail, applications shall also be moved for bails on merits, through the DLSA advocates posted in jails. The committee thanked the Jail Staff and DLSA for making sincere efforts, which caused the reduction in jail population even below the sanctioned strength. The meeting ended with a vote of thanks to the chair.
