#### OFFICE ORDER

In view of office note dated 28.03.2024, as approved by Ld. District & Sessions Judge, DLSA North, all the applications for empanelment of MM, ADJ, ASJ, Civil, Family and Consumer panel were segregated as per the panel applied for by the candidates and scrutinized by this Authority as per the conditions and eligibility criteria fixed advertisement ref. no. 230/DLSA/LAW-II/Empanelment DLSAs/2023/711-723 dated 16.01.2024 issued by DSLSA. During verification/Scrutiny of application forms, this Authority found the list of 44 applicants/applications not fulfilling the eligibility criteria and therefore these applications have been rejected summarily. Shyam, MTS, in the Office of DLSA/North East, Room No. .35, KKD Courts, Delhi w.c.f 23.04.2024 to 30.04.2024 between 11.00am to 4.00 pm and that no documents shall be accepted after 30.04.2024
