Spreading Legal Aid Mechanism

Regular Meeting with Jail Visiting Advocates, Criminal Side Advocates, Sessions Advocates, Remand Advocates and also Civil Side Advocates to take their feedback, proper monitoring of work being done, Training, orientation and sensitization.

On 29.01.2016 and 30.01.2016 interacted with Legal Aid Counsels to take their feedback, proper monitoring of work being done, orientation, motivation and sensitization.

Ld. Secretaries shall ensure regular checks so that no litigant is misguided or exploited about the legal services rendered to them and complaints about LSA if any are properly registered in a complaint register and promptly dealt with as per law.

Undersigned interacted with the litigants regularly to check that no litigant is misguided or exploited about the legal services rendered to them.

Visits by Secretaries/Panel Lawyers to jails to ascertain legal aid needs of jail inmates and identification of probable Juveniles. Measures be taken to ensure that Legal Services Clinics are in proper conditions and stationery is not only replenished from time to time but also not misused. Further, measures be taken to ensure that E-Kiosks shall remain operational.

On 12.01.2016 and 27.01.2016 undersigned visited to jail to ascertain legal aid needs of jail inmates. Inmates were interacted for identification of probable Juveniles. Legal Services Clinic was inspected and there was sufficient stationery. E-Kiosks was found operational.
