



The National Legal Services Authority (NALSA) is in the process of formulating a dedicated Scheme for the welfare of servicemen, ex-servicemen and their dependents. As part of this initiative, it is proposed to identify and empanel practising advocates who are ex-servicemen, including those who have served as Judge Advocate General (JAG), as Panel Lawyers to provide legal services/assistance under the State/District/Taluk Legal Services Authorities/Committees.

In furtherance of this objective, the District Legal Services Authorities (DLSAs), Taluka Legal Services Committees (TLSCs), and the High Court Legal Services Committees (HCLSCs) in your respective States may be requested to undertake the task of identifying practising advocates who are ex-servicemen including those who have served as JAGs, irrespective of their years of practice at the Bar.

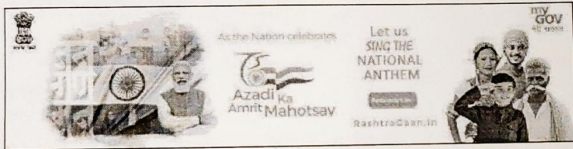
