
Office Order

By this order this Authority do hereby appoint & empanel 'Ms. Joymoti Mize' as Legal Services Advocate for West District legal Services Authority.

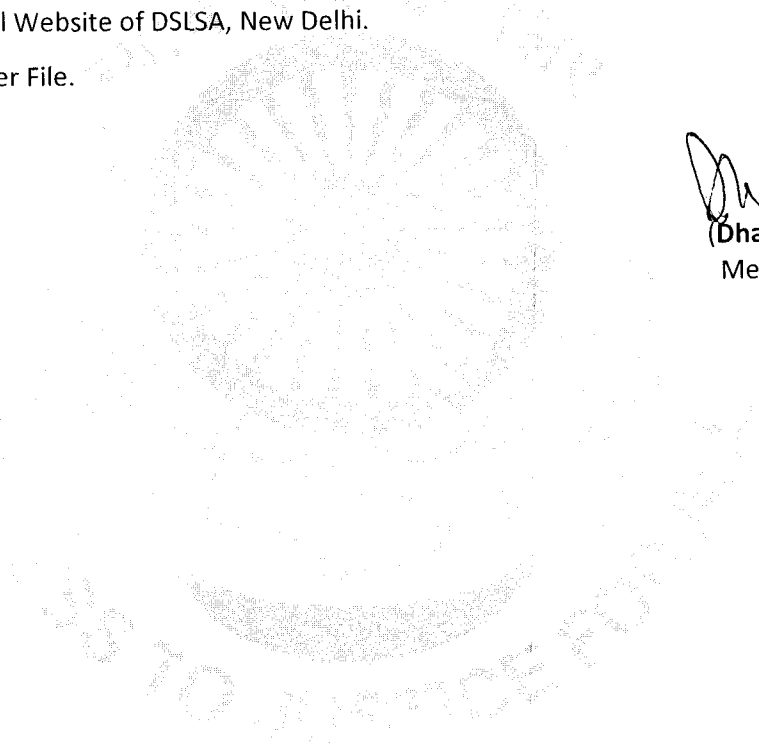
The services of such empanelled legal Services Advocate from North East States of India may be utilised for the following purposes:

2. The services of such advocates may also be utilised as interpreters for the purpose of better understanding during legal proceedings, In cases where the person hailing from North – East state happens to be a victim or the accused.
3. The services of such advocate may also be utilized for delivering lectures at legal literacy Clubs under the umbrella of Mass Legal Literacy Campaigns in Schools, Colleges and Communities.
4. The services of such advocate may also be utilized for the purpose of co-ordinating with local police in cases of disputes where the person hailing from North-East states is a party, for overcoming the language barriers and creating better understanding and communication.
