The services of such Legal Services Advocates from North-East States of India may be utilised for the following purposes:

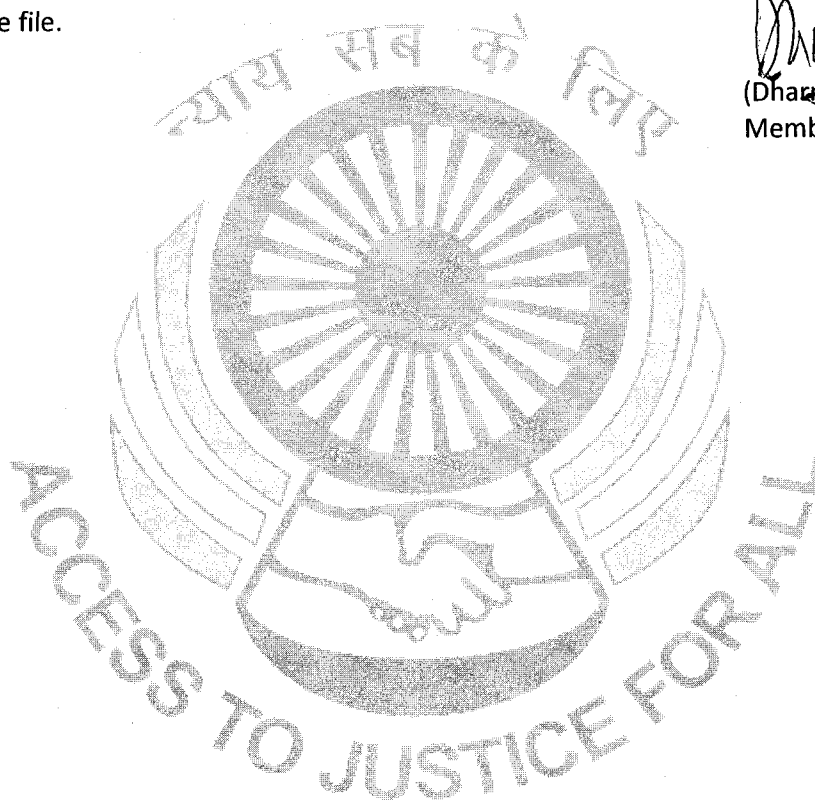
1. To provide quality Legal service to the people belonging to North-Eastern States of the Country.
