CIRCULAR

Result of Empanelment of LSAs at JJB, CWC and AILACCR

A Public Notice dated 21.04.2015 bearing no. DSLSA/Legal Aid Wing/Empanelment/2015/3318-3347, was issued whereby applications in soft format were invited from eligible candidates for five vacancies in the Juvenile Justice Boards Panel, for 04 vacancies in Child Welfare Committees Panel and for 25 vacancies in All India Legal Aid Cell on Child Rights (AILACCR) Panel.

In response to the Public Notice and the eligibility criteria, 118 applications were received on the e-mail Id i.e. legalaidthing-dslsa@nic.in of this Authority.

For the purpose of holding interviews, an Interview Board was constituted, comprising of:

1. Ld. Member Secretary - Chairman
2. Ld. Officer on Special Duty - Member
3. Ld. Project Officer - Member

The interviews were scheduled and spread over 5 working days from 18.05.2015 to 26.05.2015 and approximately 15 applicants/candidates were interviewed each day, on the assessment criteria formulated by the Interview Board.

Upon conclusion of Interview Sessions and compiling the performances; Hon'ble Executive Chairman, DSLSA, has been pleased to approve the empanelment of following Advocates as Legal Services Advocates with this Authority as per merit w.e.f. **01.07.2015** for a period of three years, subject to their satisfactory work performance on the terms and conditions as already specified in the above mentioned Public notice dated 21.04.2015.
