If this day is declared later as a Government holiday, then the tenders will be received and opened on the next working day as per the scheduled time. The undersigned will not be held responsible regarding late submission/received of tender in any manner.
- The highest tenderer, whose tender is accepted shall deposit the balance amount 4. within two days of the deposit of the initial amount. If highest bidder does not accept the offer of sale of vehicle for any reasons whatsoever it may be, and withdraws from the bidding, the EMD deposited by such bidder will be forfeited. The second highest bid amount may be considered for sale, if accepted by the Competent Authority and accordingly the second highest bid amount will be considered as the highest bid amount, subject to minimum reserve price conditions. If the ground rent so charged, exceeds the sale price deposit, then the tenderer shall cease to have any right on the vehicle and the amount deposited by him shall be adjusted towards ground rent. Tools implements of spare parts shall not be delivered with vehicle.
