The work profile of the Legal Services Counselors shall be as follows:

- Proving services in Front Office of DLSAs and this Authority as Legal Services Counselors.
- Providing free Counseling to Defence and Para Military Personnel (Serving & Non Serving)
- 3. Providing Counseling to the Rape victims and their families.
- 4. Providing counseling in case of Missing Children.
- 5. Providing their services in GRCs as per requirement.
- 6. Providing services in Legal Literacy programmes, as and when needed.
- 7. Providing services in Legal Services Clinics.

Terms and Conditions:

- Empanelment of a Counsellor with Authority would not make him/her entitled to any remuneration. Counsellors would be paid only for the services rendered as per approved fee schedule.
- 2. DLSA concerned shall be paid the honorarium to the legal Services Counsellors in accordance with the fee schedule of this Authority as per nature of duties assigned.
- 3. Payment to the Legal Services Counsellors shall be made by DLSA concern.
- 4. This Authority reserves the right to avail the services of empanelled Counsellors to perform duties in Legal Services Clinics, Gender Resource Centres, Jails, Observation Homes, Legal Literacy Clubs, Schools, Colleges, Front Office of DLSAs etc. and also for other activities/awareness programmes.
- 5. Removal from Panel: If performance of the empanelled Counsellor is found unsatisfactory or the Counsellor is found to be involved in charging or collecting or demanding any remuneration from any person in any form or is found involved in any other misconduct or he/she contravenes the Scheme of the Act, Rules and the Regulations, he/she can be summarily removed from the panel and shall also be liable for action for professional misconduct as per Regulation 7 of the Delhi State Legal Services Authority Regulations, 2002.
- 6. This Authority reserves its rights to enlarge the scope of the duty of the empanelled Counsellor in order to achieve the aim and object of "The Legal Servicers Authorities Act, 1987" and its Rules, Regulations, etc.
