## ADVERTISEMENT

**Last Date of Receipt of Application : 24.03.2020 by 5.00 p.m. through Speed Post only.**

Applications are invited on the prescribed proforma from the Citizens of India who are **Acid Attack Victims** for their rehabilitation under the Victim Compensation Scheme. Recruitment against these posts is restricted to the Acid Attack Victims relating to such offences committed within NCT of Delhi.

**Number of Vacancies: 07**

**Post: Lower Division Clerk**

**Pay Scale: Rs. 19900 to 63200 as per Pay Matrix Level-2 of 7<sup>th</sup> CPC.**

**Terms and Conditions for appointment are as follows:**

**Age:** Candidate should not be below 18 years & not exceeding 40 years as on 24.03.2020.

**Reservation:** Posts are reserved/created for rehabilitation of Acid Attack Victims only. Selection shall be preferred on the basis of percentage of acid burning from maximum to minimum.

**Educational Qualification:** Preferably 10+2 pass or equivalent from any Recognized State/Central Board of Education or above & knowledge of working on computers especially Microsoft-Office.

**Relaxation in Qualification:** Candidates who have passed matriculation (10<sup>th</sup>) or equivalent from any recognized State/Central Board of Education can also apply for the post subject to condition that upon selection candidate has to pass 10+2 or equivalent educational qualification from any recognized State/Central Board within first 5 years of his/her service failing which services of the official shall be terminated. It shall further be noted that till acquiring the requisite qualification, selected candidate shall be treated as temporary and his probation period shall start from the day candidate completes 10+2 or equivalent from recognized State/Central Board of Education.

**Procedure of Selection:** Upon scrutiny of Application and Documents, if candidate meets the minimum criteria mentioned above viz. age, qualification, experience etc. candidate will be called for Medical Examination of Acid Burning. Candidate has to produce Acid Burning Certificate with percentage of burn. Only thereafter candidate shall be called for an Interview.

List of shortlisted candidates for Medical Examination and Interview dates will be uploaded on the official website of the Authority [www.dlsa.org](http://www.dlsa.org)

Final selection of candidate shall be based upon fulfilling the aforesaid conditions, suitability of candidate and marks obtained in the Interview.

Sending application shall not confer any right upon the applicant for claiming any services/job in Authority. Upon final selection, candidate (who have already passed the 10+2 or equivalent or possess more educational qualification) shall be on probation for one year which may be extended as per rules.

Passing the English typing test with minimum speed of 30 w.p.m. on computer within one year will be a condition for all selected candidates.

Selected candidate may be posted at any office of DSLISA within the periphery of Delhi/New Delhi.
